9 **ALASKA REDISTRICTING BOARD’S NOTICE**
10 **REGARDING ADOPTION OF FINAL PROCLAMATION PLAN**

11 In its Opinion (Slip Op. 7646) dated April 21, 2023, the Alaska Supreme Court
12 directed that the Alaska Redistricting Board (“Board”) could make a showing to this
13 Court if it wished to do another round of redistricting, or the 2022 interim plan could
14 become the final plan.

15 The Board met in a public meeting on May 15, 2023. After public testimony
16 and discussion, the Board unanimously approved a motion to adopt the 2022 interim
17 plan as the Final Proclamation Plan. The Final Proclamation will be published to the
18 Board’s website.

20 Pursuant to Article V, Section 11, the Board understands that legal challenges to
21 the Final Proclamation Plan may be timely filed within 30 days of the Plan’s adoption
22 on May 15, 2023, which means legal challenges are due by June 14, 2023. This Notice
23 will be published to the Board’s website to remind members of the public of the
24 deadline for any additional legal challenges.
